What is the purpose of this update?

This document tells you how the Lifetime Overseas Shares Fund No.3 (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime Overseas Shares Fund No.3 seeks to track (before annual fund charge and tax) the MSCI World Index NR ex NZ, Tobacco, Controversial and Nuclear Weapons, 50% hedged to NZD. The Fund provides exposure to international share (equity) investments and is expected to experience high volatility.

What are the risks of investing?

Risk indicator for the Lifetime Overseas Shares Fund No.3

Specific risk



Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$828.50 (that is 8.28% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$828.50 for the year.
