What is the purpose of this update?

This document tells you how the Lifetime Overseas Shares Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime Overseas Shares Fund seeks to track (before annual fund charge and tax) the MSCI World Index NR ex NZ, Tobacco, Controversial and Nuclear Weapons, 50% hedged to NZD. The Fund provides exposure to international share (equity) investments and is expected to experience high volatility.

What are the risks of investing?

Risk indicator for the Lifetime Overseas Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.




What does the fund invest in?
