What is the purpose of this update?


Description of this fund

The Lifetime Overseas Bond Fund No.2 seeks to track (before annual fund charge and tax) the Bloomberg MSCI Global Aggregate SRI Select ex-Fossil Fuels Index, 100% hedged in NZD. The Fund provides exposure to international fixed interest investments and is expected to experience low to moderate volatility.

What are the risks of investing?

Risk indicator for the Lifetime Overseas Bond Fund No.2



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.



Lifetime Overseas Bond Fund No.2 - Annual Returns

Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$230.33 (that is 2.30% of his initial \$10,000). Ben also paid \$0.00 in other charges This gives Ben a total return after tax of \$230.33 for the year.


What does the fund invest in?
