What is the purpose of this update?

This document tells you how the Lifetime Cash Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (Lifetime) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime Cash Fund seeks to track the S&P/NZX Bank Bills 90-Day Index (before annual fund charge and tax). The Fund invests primarily in New Zealand cash or other short-term investments such as term deposits and is expected to experience low volatility.

Specific risk

At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.



Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$418.69 (that is 4.19% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$418.69 for the year.




Actual investment mix
