What is the purpose of this update?

This document tells you how the Lifetime International Shares Fund No.2 (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (**Lifetime**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime International Shares Fund No.2 seeks to track (before annual fund change and tax) the MSCI World Index NR ex NZ, Tobacco, Controversial and Nuclear Weapons, 50% Hedged in NZD. The Fund provides exposure to international shares and is expected to experience high volatility.

What are the risks of investing?

Risk indicator for the Lifetime International Shares Fund No.2



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

In addition to the general investment risks, you should be aware this Fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.



Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$866.21 (that is 8.66% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$866.21 for the year.




Actual investment mix
